Driving Agreement for Anna Bennett October 2010

I, Anna Bennett, agree to abide by the following rules relating to my driving and the use of any automobile. If at any time I violate this Agreement I understand that my driving privileges will be forfeited to the extent my parents determine appropriate in light of the nature of the violation and all of the surrounding circumstances.

- 1. I will never "drink and drive" or drive while under the influence of alcohol or any illegal drug. There will never be any alcoholic beverages or illegal drugs in my car at any time. I understand that any violation of this rule may result in the forfeiture of my driving privileges until the age of 18.
- 2. I will never ride in the automobile of a friend or acquaintance when the driver is drinking or under the influence of drugs or alcohol. Violation of this rule will result in a loss of driving privileges for a period to be determined by my mom and dad.
- 3. Should I find myself in one of the situations described in rules 1 or 2 above, I will park or exit the automobile and contact my parents. They will provide me with a ride home under a "no questions asked" policy.
- 4. Should I get a traffic ticket, I agree to pay for the ticket as well as the increase in insurance premiums. Traffic tickets vary from \$75 \$250. The increase in the insurance premiums may vary from \$350 \$1200 per year.
- 5. Should I get in an accident, I agree to pay for the damages that I cause that are not covered by auto insurance.
- 6. I will not transport more passengers than there are seat belts in the car and I will not start driving until all car passengers have buckled up.
- 7. Until I reach the age of 17, I agree not to eat, change CDs or talk on the phone while driving (including hands-free). For the first six months after I obtain my license I will not change the radio station when the car is moving. These activities all greatly increase the risk of accidents.
- 8. I agree to keep the cars I drive clean inside and out.
- 9. I agree to not street race or take a vehicle without parental permission/knowledge.
- 10. I agree to carry a AAA card and cell phone at all times.
- 11. I agree to maintain a GPA of 3.5 or higher or I will be responsible for 100%

of my car insurance until my GPA is above 3.5

- 12. I agree to wear my seat belt 100% of the time I am in ANY vehicle and I will wear it properly.
- 13. I agree to pay for gas **above** the need to get to school or run errands for the family.
- 14. I agree to follow Washington State laws regarding teen driving. More specifically:
 - a. For the first six months after obtaining my driver's license, I will not transport passengers under the age of 20 except for family members unless an adult driver is also in the car.
 - i. The first violation of this prohibition will result it a loss of driving privileges for one week. The second violation of this prohibition will result in a loss of driving privileges for three weeks.
 - b. I agree to NOT be a passenger of a driver who is still within their 6 month Period
 - c. I agree that I CAN say 'no' to a peer if they need a ride while I am still under this WDL restriction
 - d. Adding Passengers –I agree to discuss with parents as to who may or may not be a passenger while I am driving
 - e. Until I am 17, I will not drive between the hours of 1:00 a.m. and 5:00 a.m. unless a driver who is at least 25 years old is in the car.
 - i. The first violation of this prohibition will result in a loss of driving privileges for one week. The second violation of this prohibition will result in a loss of driving privileges for three weeks.
